## MEETING MINUTES Thursday, May 28, 2015

The Fire Chief reviewed the pending installation of equipment next week on the Noble Energy site; the new staffing schedule; update of Station 22 improvements; ordering the new beds; organizational changes; and budget changes to be presented later.

#### B. Staff Report/2014 Audit.

#### C. Treasurer Report.

A transfer is being made for \$546,000 which includes the Department insurance renewals for \$70,000, the final tower truck lease payment for \$172,000, and a reimbursement of \$258,000 to the Department. After \$21,146 in deposits so far for May, we've received 98.99% of collections and anticipate a year-end carryover of \$210,500 after making an additional principal payment of \$500,000.
